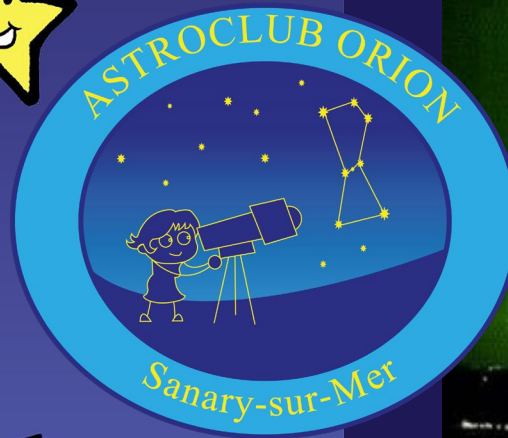

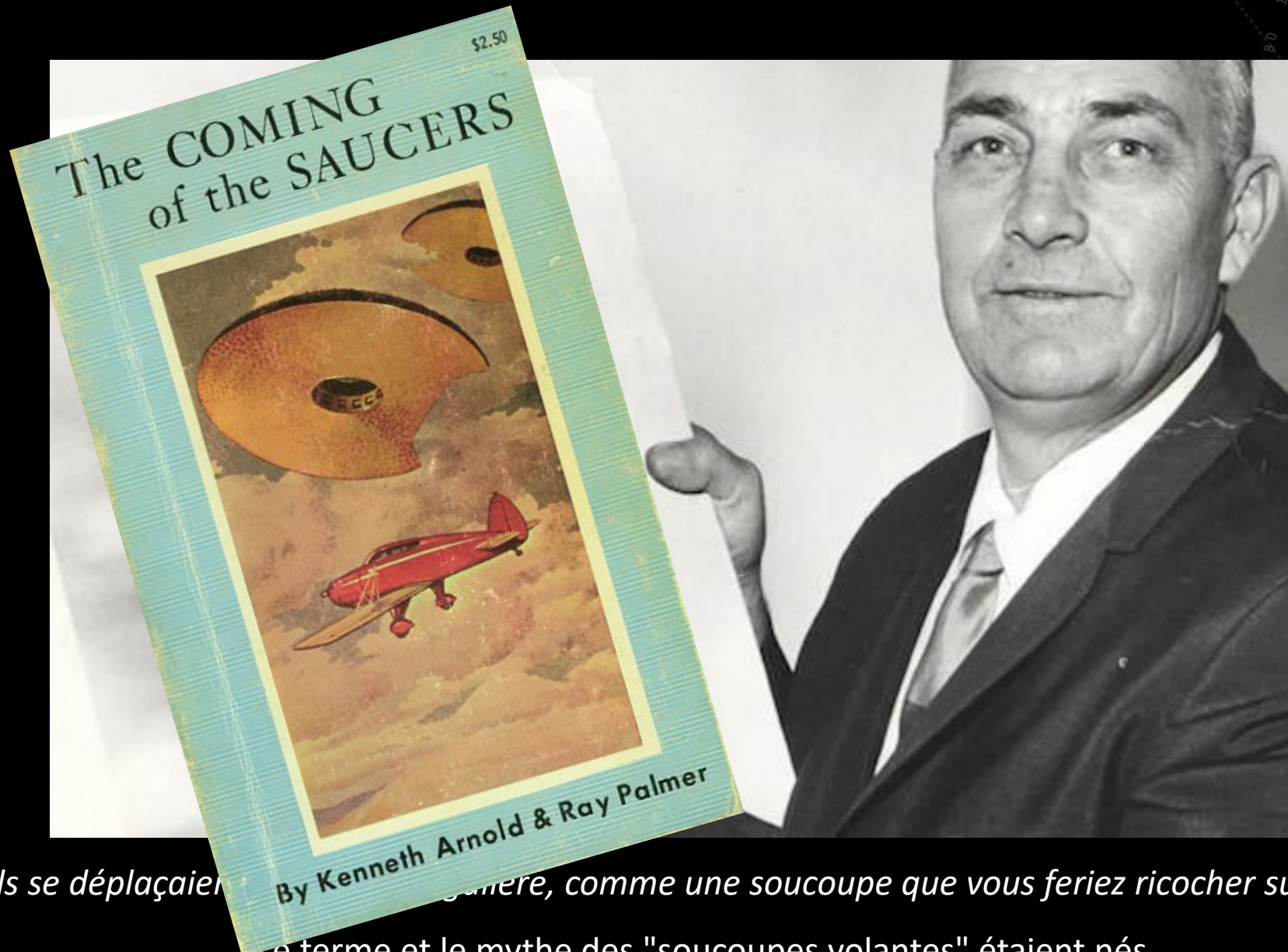

## Claims Army Is Stacking Courts Martial

Indiana Senator Lays Protest Before Patterson

Washington, July 8 (AP)—Senator James H. Doolittle today demanded that "the high command in the European theater is stacking courts martial defendants in courts martial."

In a letter to Secretary of War Patterson detailing a full investigation of army military trial procedure, Senator Doolittle stated that the bill was documentary proof that:

1. "Prisoners are not being permitted to employ either civilian or military counsel of their own choice in the preparation and presentation of their defense."

2. "Every effort is being made to prevent attorneys who were retained with the defendant's knowledge from appearing in court."

The Indiana senator made public a copy of an informal "opinion" which he said was signed by Brig. Gen. Cornelius H. Ryan, assistant deputy, military government headquarters for Germany, and written by Col. Francis H. Vandewater, senior staff sergeant that the routing slip substantiated his charges.

The bill, addressed to the chief of staff, USPT (presumably US Forces, European Theater), was dated last Oct. 23.

It called attention to the impending arrival of Earl J. Carroll and Thomas Lester Wiley, California attorneys, as well as special defense counsel for the prisoners then awaiting trial by military courts martial at Frankfurt Am Main.

Doolittle identified Carroll as counsel in the court martial of Col. James A. Kahan in the Lubbock court-martial proceedings.

Carroll, then at army camp, resigned as assistant prosecutor in the Lubbock trial after signing a statement which stated that he was being made by army legal authorities to withdraw higher officers in the case, Kahan was later sentenced and killed.

The meeting also said Carroll had received widespread publicity by violent attacks on the system of military justice and added "It is understood that Wiley is an instructor of defense attorneys, and...

## House Passes Tax Slash by Large Margin

Defeat Amendment by Demos to Remove Many from Rolls

Washington, July 8 (AP)—The House passed today the Republican-backed bill to cut income taxes by \$4,000,000,000 annually for 4,000,000 taxpayers beginning Jan. 1.

It came to the Senate where approval also is forecast. The vote was 312 to 11, or more than the two-thirds majority needed to override a presidential veto.

The action, which may encourage another presidential veto, came after Speaker Martin Dies, personally appeal to the House to pass the bill by such a decisive vote as to preclude the possibility of the people should have this delayed justice.

The measure is identical with one passed by President Truman June 18 as "the wrong kind of a reduction at the wrong time" — except that the effective date is changed from July 1, 1947 to Jan. 1, 1948.

Congress leaders expect to have the revised bill on its way to the desk before the week ends. The House passed the bill after the Republicans had had a proposal to remove income tax rates which would have reduced taxes by \$2,750,000,000 and removed 4,000,000 low-income persons from the tax rolls completely.

## No Details of Flying Disk Are Revealed

Roswell Hardware Man and Wife Report Disk Seen

The intelligence office of the Sixth Army Air Force announced today that the field has come into possession of a flying saucer.

According to information received by the department, over authority of Maj. J. A. Marvel, intelligence officer, the disk was removed on a ranch in the Roswell vicinity after an unidentified rancher had notified General Connelley, that he had found the instrument on his premises.

Maj. Marvel and a detail from his department went to the ranch and recovered the disk, it was stated.

After the intelligence office here had inspected the instrument it was flown to "higher headquarters."

The intelligence office stated that no details of the saucer's construction or its appearance had been revealed.

Mrs. and Mrs. Dan Wilson apparently were the only persons in Roswell who have seen what they thought was a flying disk. They were sitting on their porch at 181 South First, last Wednesday night at about 10:30 when a bright glowing object zoomed out of the sky from the southeast, came in a northwesterly direction at a high rate of speed.

Wilson, called Mr. Wilson's attention to it and both ran down the street to watch. It was in fact less than a minute, perhaps 30 seconds, before it disappeared.

Wilson said that it appeared to him to be about 1,000 feet high and about 100 feet in diameter. In appearance it looked oval in...

Washington, July 8 (AP)—An agreement averring a nationwide soft coal strike was averted today by John L. Lewis and a majority of the bituminous operators.

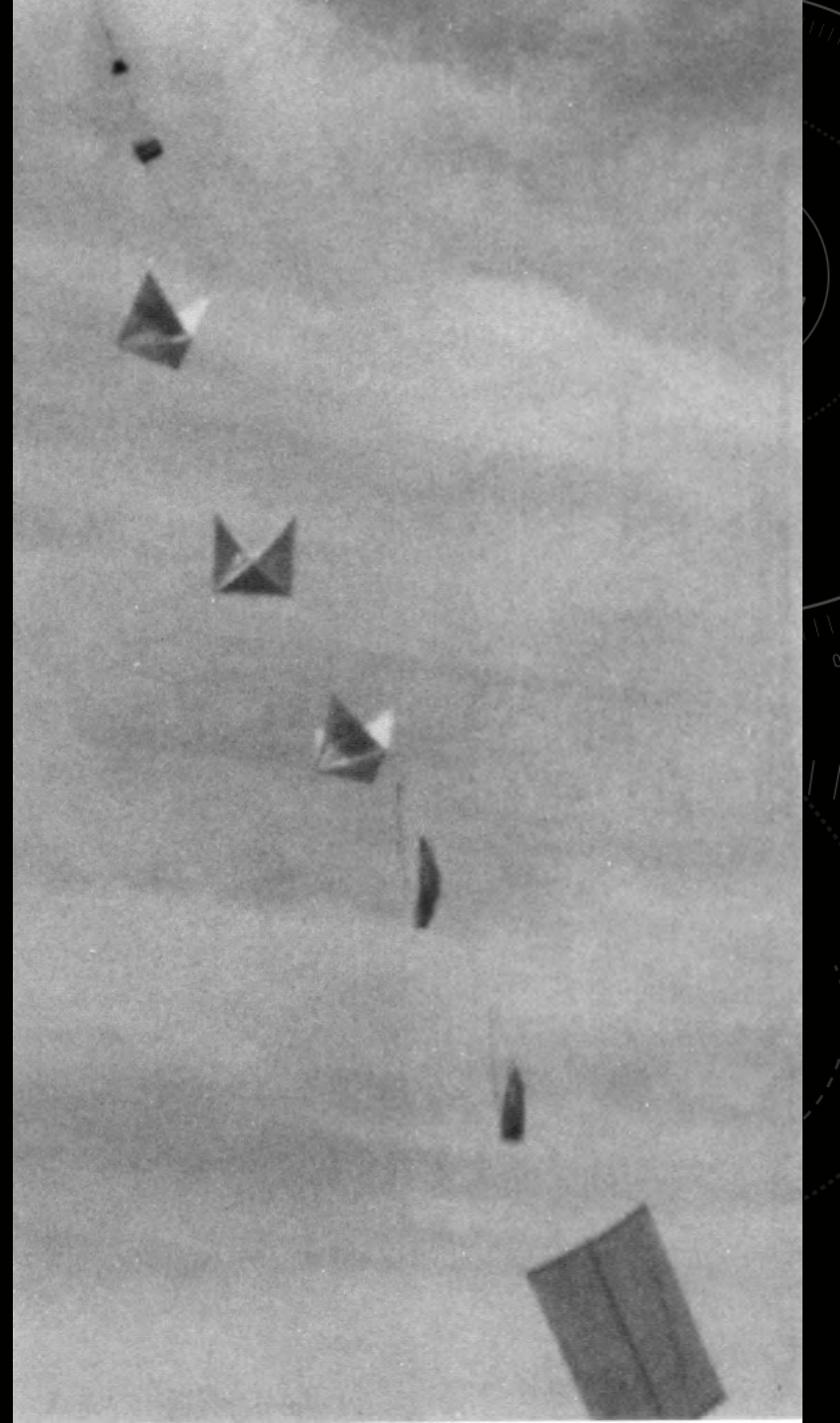
